The Certifying Party hereby certifies it has completed the following in relation to Regions Data (complete all that apply):

Clearing	Overwriting is an acceptable method of clearing. Overwrite media by using validated overwriting technologies/methods/tools.
Purging	Executing the secure erase firmware command on a disk drive and degaussing are acceptable methods of purging. Degaussing is not effective for optical media (e.g., CDs, DVDs).
Destroying	Can be accomplished using a variety of methods including, but not limited to, disintegration, incineration, pulverizing, shredding, and melting. Optical media must be destroyed via pulverizing, shredding or incineration (must be reduced to white ash). Hard Copy (Paper) must be destroyed using crosscut shredders which produce particles that are 1 mm x 5 mm in size or smaller or pulverize/disintegrated using disintegrator devices equipped with a 3/32 in security screen.
Data Transfer	At Regions written instruction, the Data, to the extent requested, has been transferred to a Company authorized by Regions. A copy of the written request from Regions authorizing the transfer is attached here to. Except as transferred, the Data has otherwise been destroyed.
Data Retention	In accordance with the terms of the contract between Regions and Certifying Party OR Certifying Party's Record Retention Policy (a copy of which is attached hereto), the Certifying Party has retained Regions Data. Within 30 calendar days of the end of the Retention Period the certifying party shall ensure the destruction of all Regions data in accordance with the NIST Special Publication 800-88r1 and provide certification of the same signed by an officer of the Certifying Party to Regions.
